During 2018, RiverLink continued its critical River revitalization work by encouraging watershed communities to experience and learn about the French Broad River. We also carried out important land and water conservation programs.

CONSERVATION -RiverLink took another step forward in the transformation of a former junkyard into a public park by hiring internationally-recognized landscape architecture firm, Nelson Byrd Woltz, to lead a design team to create the Park Master Plan. A kickoff of the design process was held in late May, and two subsequent public events took community input and allowed people to walk on the site in October when the Master Plan was in rough draft form. The designers provided a copy of the Plan in December and the board will approve it in February 2019. The Givens Estates Innovative Stormwater Control Project, funded by NC Clean Water Management Trust Fund, entered the construction

phase that will result in 5 Stormwater Control Measures being designed and installed to control runoff in the 100-acre watershed that flows into the impaired Dingle Creek. A research phase will begin in 2019 that will seek to inform policy makers and engineers on effective stormwater management in the steep slopes in mountains of NC. RiverLink was also an instrumental partner in the creation of the French Broad River Tree & Riparian Enhancement Plan for the Asheville Riverfront.

LEARN - Our K-12 education program grew in 2018 with the creation of the RiverRATS program, an experiential education program that fosters an appreciation and understanding of aquatic ecosystems. Grant funding for this program allowed for the purchase of classroom and instream tools to support NC STEM curriculum with a portable stream table, dissecting microscopes, and backpack electrofisher. 3300 students were

educated at more 38 local schools in the 8-county watershed. RiverLink also celebrated its tenth year of RiverCamp with four weeks of day camps for grades 3-8 focused on the exploration of the French Broad Watershed. We had funding to provide scholarships for 20% of the students. We also partnered with a local school to install a 275 gallon rainwater catchment cistern on their campus.

EXPERIENCE - We continued a strong legacy of providing ways for watershed communities to experience the watershed. Our residential rainwater control program, WaterRICH, provided community workshops to install a rain garden at a local school and we hosted three rain barrel workshops. We also led campaigns to name two streams in North and West Asheville. We leveraged 144 volunteer hours for the Givens Estates See Part III, Ln 4c statement
